The European Parliament and Council Regulation (EC) No 1406/2002¹ provides the legal basis for the establishment of the European Maritime Safety Agency (EMSA).

The goal of the Agency is to provide technical and scientific assistance to the European Commission and the Member States on matters relating to the proper implementation of European Union legislation on maritime safety and pollution by ships. To do this, one of EMSA's tasks is to improve cooperation between Member States in all key areas. This includes undertaking a range of actions related to design, construction and operation of all types of merchant and fishing vessels.

In April 2004 EMSA was also given some additional tasks by the European Council and the European Parliament related to oil pollution response, ship security and training of seafarers.

EMSA invites you to send your application for the recruitment process of Project Officer for Environmental Protection. The position will be attached to Department B 'Implementation', Unit B.3. 'Marine Environment, Training and Statistics'.

Functions and Duties:

The successful candidate, reporting to the Head of Unit, will be:

- Providing the unit with input of relevant European and international laws pertaining to the protection of the marine environment and maritime safety.
- Providing the Head of Unit with information and assistance on matters of marine environment protection. Most specifically on issues regarding:
 - o Port reception facilities for ships' waste and cargo residues;
 - o Ship recycling.

The successful candidate's functions would include:

 Preparing analyses and reports on the implementation and development of EU legislation on the above-mentioned issues;

- Organisation of workshops and studies in conjunction with the relevant unit members;
- Participation in the Agencies inspection visits to assess the implementation of Directive 2000/59/EC in the Member States
- Preparing and representing EMSA at international meetings and conferences on port waste reception facilities and ship recycling.

A. ELIGIBILITY CRITERIA

Qualifications and experience required:

A.1. Education:

- A level of education which corresponds to completed university studies attested by a diploma when the normal period of university education is four years or more, or;
- A level of education which corresponds to completed university studies attested by a diploma and appropriate professional experience of at least one year when the normal period of university education is at least three years.

A.2. Experience:

- At least six years of proven relevant professional experience acquired after the award of university diploma when the normal duration of university education is four years, or;
- At least seven years of proven relevant professional experience acquired after the award of university diploma when the normal duration of university education is three years.

A.3. Language skills:

The main working language in the field of maritime safety is English. Candidates must therefore have a very good command of oral English, as well as in writing, with a satisfactory knowledge of at least one other official language of the European Union to the extent necessary for the performance of the above mentioned duties.

A.4. General Conditions: In addition, in order to be eligible the candidate must:

- Be a national of one of the Member States of the European Union or of Iceland or Norway;
- Be entitled to your full rights as a citizen²;
- Have fulfilled the obligations imposed on you by the laws concerning military service;
- Meet the character requirements for the duties involved;
- Be physically fit to perform the duties linked to the post³.

B. SELECTION CRITERIA

B.1. Essential:

• At least three years of the six years of proven relevant professional experience must be specifically related to the functions and duties mentioned in this call;

- Good knowledge of EU legislation and policies in the field of maritime safety, environmental policies and protection of the marine environment;
- Good knowledge of the functioning of the IMO and EU's role therein;

- Thorough knowledge in the field of port waste reception facilities;
- Thorough knowledge in relation to the international and European legislative framework and policies relating to ship dismantling/recycling, as well the MARPOL convention, Basel Convention on transboundary movement of hazardous waste and the Hong Convention on Ship Recycling;
- Good analytical skills;
- Excellent sense of responsibility and initiative.

B.2. Advantageous:

- Experience of international negotiations;
- Good knowledge of MS Office software, internet, e-mail;
- Knowledge of a third EU language.

The advantageous criteria will be considered by the Selection Board depending on the number of applicants meeting the essential criteria.

Conditions of Employment:

- This vacancy notice concerns a Temporary Agent position, pursuant to Article 2 a) of the Conditions of Employment of other servants of the European Communities.
- The initial duration of the contract is three years, with possibility of renewal.
- The successful candidate will be recruited in the grade AD 7.
- The basic monthly salary, before any deductions or allowances, at 1 July 2010 for grade AD 7 first step is EUR 4732.89.
- In addition to the basic salary, staff members may be entitled to various allowances, such as an expatriation allowance (16% of basic salary), household allowance, dependent child allowance and education allowance. The salary is subject to a Community tax deducted at source and staff members are exempt of national taxation.
- Please note that recruitment is done in the first or second step of the indicated grade, depending on the duration of the acquired professional experience.
- EMSA offers a comprehensive welfare package including pension scheme, medical
 accident and occupational disease insurance coverage, unemployment and invalidity

- If you are invited to an interview you will be asked to submit supporting documents to prove the information provided in your application;
- You may apply in any of the official languages of the European Community, but it
 would be helpful to apply in English in order to facilitate the selection process.
 However you are requested to state your educational qualifications and positions
 held in the language of origin.

The Selection Process:

All candidates will receive an acknowledgement of receipt for their application. For each selection process a Selection Committee is nominated. The Selection Committee will evaluate all applications and select those candidates meeting the eligibility criteria and matching best the selection criteria required in this vacancy notice. The **selected candidates** will be invited to **pass one or several written exams** related to the job profile and to take part in a **selection interview**.

During this recruitment phase, the selected candidates will be evaluated by the Selection Committee. After the interviews, the Selection Committee will draw up a list of the most suitable candidates. The **Appointing Authority will select the successful candidate** and inform him/her accordingly. As soon as this decision is taken, **all candidates will receive an information letter.**

Please note that a binding commitment can only be made after verification of all conditions and will take the form of a contract signed by the Executive Director.

The reserve list will remain valid for a period of 1 year following its establishment. Therefore candidates whose name will be put on a reserve list could be offered a contract during this period of time.

Please note that the **selection process may take several months** to be completed and that **no information** will be released **during this period**. Once a selection process has been completed, its status will be displayed on our web site.
