DECISION OF THE ADMINISTRATIVE BOARD OF THE EUROPEAN MARITIME SAFETY AGENCY REGARDING THE IMPLEMENTING RULES OF THE NEW STAFF REGULATIONS

The European Maritime Safety Agency,

Having regard to the Council Regulation (EC) n° 723/2004 of 22 March 2004 amending the Staff Regulations of officials of the European Communities and the Conditions of Employment of other servants of the European Communities¹,

Having regard to the Council Regulation (EC) n° 1406/2004 of 27 June 2002 establishing a European Maritime Safety Agency, and in particular article 6 thereof²,

Having regard to the Decision of the Administrative Board of EMSA of 30 April 20043,

Having regard to the list of implementing rules adopted by the Commission listed in Annex 1 of this decision,

Has decided:

Article 1

The Implementing Rules listed in Annex 1 of this decision will apply to EMSA staff as of 1 November 2004

Article 2

Article 3 (2) and 3(3) will be replaced as follows: In agreement with the Commission, the Executive Director shall, by 30 June 2005 at the latest, submit a proposal for a decision of the Administrative Board for adapting the remaining implementing rules to the needs of the European Maritime Safety Agency

Article 3

The Executive Director is in charge of undertaking the necessary steps for the implementation of the present decision.

DECISION OF THE ADMINISTRATIVE BOARD OF THE EUROPEAN MARITIME SAFETY AGENCY OF 30 APRIL 2004

The Administrative Board of the European Matitime Safety Agency

Having regard to the Council Regulation (EC) n°723/2004 of 22 March 2004 amending the Staff Regulations of officials of the European Communities and the Conditions of Employment of other servants of the European Communities¹.

Having regard to the Council Regulation (EC) n°1406/2004 of 27 June 2002 establishing a European Maritime Safety Agency, and in particular article 6 thereof ²

Having regard to the decisions of the Commission setting up implementing rules for the application of the amended Staff Regulations of officials of the European Communities and the Conditions of Employment of other servants of the European Communities

Has decided:

Article 1

Without prejudice of article 6 of the Council Regulation (EC) n° 1406/2002 above mentioned, a mandate is given to the Executive Director to implement the amended Staff Regulations applicable to officials and other servants of the European Maritime Safety Agency from 1 May 2004 under the conditions laid down in articles 2 and 3.

Article 2

With a view to provide clarity on the legal framework and rules applicable to the relation between the European Maritime Safety Agency and its staff, the implementing rules adopted by the Commission, as listed in annex 1 shall apply by analogy.

The provisions will apply from 1 May until the date mentioned in article 3 · § 3.

Article 3

- (1) From 1 May 2004, the Executive Director shall undertake the evaluation of the necessary adaptations of the implementing rules of the above mentioned staff regulations, in consideration of specific needs or situations encountered in the European Maritime Safety Agency.
- (2) In agreement with the Commission, the Executive Director shall by 1 January 2005 submit a proposal for decision of the Administrative Board for adapting the implementing rules to the needs of the European Maritime Safety Agency.
- (3) The regime approved by the Administrative Board will come into force at the date the final decision of the Board will be notified to the staff and the Commission, and not later than 15 February 2005.

The amended regime will then replace the provisions implemented in accordance with article ${\bf 2}$.

Article 4

The present decision is notified to the Staff and to the Commission.
