## DECISION OF THE ADMINISTRATIVE BOARD AMENDING 2007 BUDGET OF THE EUROPEAN MARITIME SAFETY AGENCY

The Administrative Board of the European Maritime Safety Agency,

Having regard to the European Parliament and Council Regulation 1406/2002, of 27 June 2002, setting up a European Maritime Safety Agency (hereafter EMSA or the Agency);

Having regard to the Financial Regulations of the Agency adopted by the Administrative Board on 3 July 2003 and in particular article 32 thereof,

Having regard to the contribution agreement 2007/133-112 "CARDS Countries and EMSA" signed on 30 May 2007 between EMSA and the European Commission to support the participation of CARDS countries (Bosnia & Herzegovina, Serbia, Montenegro, the former Yugoslav Republic of Macedonia and Albania) in EMSA work in 2007 and 2008.

## Whereas:

Article 28 of the EMSA Financial Regulation stating "any amendment to the budget, including the establishment plan, shall be the subject of an amending budget adopted by the same procedure as the initial budget, in accordance with the provisions of the constituent instrument and Article 27"

## HAS DECIDED AS FOLLOWS:

EMSA 2007 budget shall be amended as follows:

- In the statement of revenue, in the already existing budget line 202 :
  - To modify the name "Subsidy from Phare- DG Enlargement" into "EC Funds for candidate and potential candidate countries<sup>1</sup> and European Neighbourhood policy countries<sup>2</sup>"
  - To modify the comments from "PHARE multi-beneficiary programme on Participation of Romania, Bulgaria, Croatia and Turkey in meetings organised by EMSA" into "EC Funds to finance the participation of candidate, potential candidate countries and countries participating to the European Neighbourhood Policy in EMSA's activities"

- In the statement of Expenditure to add one new budget line as follows:
   Budget line item: 3303
  - Title: "EC Funds to finance the participation of to modify the name "Subsidy from Phare- DG Enlargement" into "EC Funds for candidate and potential candidate countries and Neighbourhood policy countries"in EMSA's activities"
  - Comments: Organisation of EMSA meetings, workshops and seminars on maritime safety, security and pollution prevention for experts coming from candidates, potential candidates countries and/or countries participating in the European Neighbourhood Policy"
