The European Maritime Safety Agency is one of the European Union's decentralised agencies. Based in Lisbon, the Agency provides technical, operational and scientific assistance to the European Commission and Member States in the fields of maritime safety, maritime security, prevention of, and response to, pollution caused by ships as well as response to marine pollution caused by oil and gas installations. The Agency also contributes to the overall efficiency of maritime traffic and maritime transport.

EMSA invites you to send your application for a Seconded National Expert as Project Officer for Marine Accident Investigation. This position will be attached to Unit B.2, 'Ship Safety', in the 'Accident Investigation Section'.

The initial duration of the secondment is one year with possibility for extension.

The place of employment is Lisbon, Portugal.

Functions and Duties:

Reporting to the Head of Unit, the Project Officer for Marine Accident Investigation will be responsible for:

- Analysing marine casualties and investigation reports and advising on best practices;
- Collecting, comparing and evaluating information on how Member States deal with accident investigation;
- Supporting the implementation of operational support to Member States in the investigation of very serious and serious casualties;
- Assisting the Commission and Member States in the implementation of the Directive of the European Parliament and of the Council, establishing the fundamental principles governing the investigation of accidents in maritime transport;
- Assisting in the conduct of any other activity EMSA may be tasked with in the field of accident investigation.

Main skills and qualifications:

- University degree or equivalent qualification or professional experience;
- At least three years of experience as a marine accident investigator having worked on safety investigations in an accident investigation body, acquired after the award of the required qualification. If no university degree or equivalent qualification has been acquired, seven years of relevant experience is required, of which three must be as a marine accident investigator;
- Thorough knowledge of legislation and instruments on marine casualties (including SOLAS and the Directive of the European Parliament and of the Council, establishing the fundamental principles governing the investigation of accidents in maritime transport);
- Good level of written and spoken English;
- Experience in training and familiarity with casualty analysis will be considered as assets.

Submission of applications:

Each application shall contain the following documents:
