The place of employment is Lisbon, Portugal.

Functions and Duties:

Under the responsibility of the Head of Unit B.3, 'Environment & Capacity Building' the successful candidate will be responsible to:

- Develop, update and deliver training in accordance with preset training activities agreed with the EU Member States and Enlargement countries' representatives;
- Support capacity building projects for enlargement countries;
- Prepare and participate in missions organized for the EU Members States, and Enlargement countries:
- Develop e-learning modules in accordance with preset training activities agreed with the EU
 Member States and Enlargement countries' representatives;
- Support as required in training or other capacity building activities organized by the Unit, in particular for project financed for ENP countries.

Main skills and qualifications:

- University degree or equivalent qualification or professional experience;
- At least 3 years of professional experience, in the area of the above-mentioned functions and duties, acquired after the award of the required qualification. When no university degree or equivalent qualification has been acquired, 7 years of experience is required, of which at least 3 must be in the area of the above-mentioned functions and duties;
- Proven Experience in developing and delivering lectures in the field of maritime domain;
- Excellent knowledge of European legislation in the field of maritime safety, security and environmental protection and EU institutions;
- Very good knowledge of IMO and ILO and their main conventions
- Strong ability to communicate effectively both orally and in writing;
- Excellent level of written and spoken English.
