The tender shall include in the bid all necessary services related to the loading and unloading of the equipment and of the dispersant onto/from the transport means.  When preparing their bid, under transportation, tenderers must consider the costs of associated logistics, loading and unloading capacities, insurance during transportation and additional appropriate wrap up and protection.
