Answer to question 03:

The way, in which the bids should be submitted is indicated under Points 2 and 3 of the Invitation to Tender N° EMSA/OP/12/2015, published on the Procurement Section on the EMSA website (www.emsa.europa.eu), which read as follows:



2. Tenderers who wish to submit an offer are invited to send to the Agency a bid duly signed by their authorised representative, together with three copies of their bid, strictly identical to the original bid (total: 1 original and 3 copies). Bids can be submitted in three different ways:

(a) either by registered post

in this case the bid should be posted not later than 23/04/2015 (the stamp of the **post office** acting as proof).

(b) or by hand-delivery

in this case hand delivery should be made not later than 16h00 (Lisbon local time) on 23/04/2015. A dated and signed receipt issued by an official of EMSA has to be requested by the person delivering the bid as proof of delivery of the bid.

(c) or by private courier service

in this case the bid should be 'deposited' with the Private courier service not later than 23/04/2015 (the slip issued by the private courier services acting as proof).

In whichever form the bid is submitted, the following address should be used:
