SafeSeaNet monthly report

April 2008

1 - Background information

The purpose of the monthly report is to present the latest specific measurable elements and figures, thereby providing a full and clear picture of the current status of SafeSeaNet. The report is made available to EMSA, the Commission and the Member States for their further analysis and conclusions may be drawn from it on current usage of the SSN system. It provides statistical elements on the quantity of information provided to SSN and section 4 gives an indication of the quality of data.

The objective of indicating the "data quality" is to assist MS in understanding those areas where their performance must be improved.

2 - Type of information

2.1 – SSN Notifications

EMSA comment – There are still many Ship Notification messages not including information on the destination of vessels. Overall percentage of unknown destinations remains unchanged.

4.2 – MRS reported in SafeSeaNet

EMSA comment – Apart from Ship (MRS) Notifications provided by Slovenia (Slovenia is a part of the ADRIREP Mandatory Reporting System), there are no other Ship (MRS) Notifications reported to the SSN. Subject to the EMSA information, figure 1 illustrates existing MRS systems in EU waters.

EMSA comment –Spain, Finland, Lithuania and Port of Rotterdam (Netherlands), and recently joined to SSN United Kingdom do not provide information for vessels leaving their ports with HAZMAT cargo. Number of unknown destinations has increased in April in comparison to March. In case of Belgium, the percentage of unknown destinations has almost doubled since March.

¹ Inbound vessel: the sender of the notification (NCA or LCA) and the next port of call belong to the same MS. Outbound vessel: sender (NCA or LCA) and next port of call belong to different countries. Unknown: the next port of call is unknown (Locode ZZUKN).

EMSA comment – Finland and Norway have recorded a decrease in availability of the messages. Their messages are not available on request. Spain, Poland, Port of Rotterdam (Netherlands) and Malta have improved since last month. However, in case of Malta still not all messages are available.

4.5 – Hazmat Notification contact details

During the month of April MSS verified the contact details included in the Hazmat notification/responses messages. Checks were performed during office hours. Table below shows:

- How details were provided, whether in XML format, downloadable document or by e-mail or fax when requested by telephone.
- When those details were provided through the phone & fax possibility, the MSS has contacted the indicated telephone number. The outcome of those checks is included in the "Comments" column.

4.6 – Alert notifications

EMSA comment – Apart from Netherlands, there are no Member States providing "Alerts". In the case of the Netherlands, the number of "Alerts" provided is 6 since January.
