BALTIC STAKEHOLDERS PAY VISIT TO EMSA


On 23 January, a group of 30 participants visited EMSA as part of the "Baltic Leadership Programme for Maritime Safety and Security". They were representing maritime authorities and organisations in the Member States around the Baltic Sea as



well as Norway and Russia. The morning was dedicated to learning more about EMSA's tasks, future challenges and revised Founding Regulation. Visitors then gave a lunchtime presentation to EMSA staff on

the theme of "Regional work to advance maritime safety and security in the Baltic Sea Region", before entering into more detailed discussions on safety and security in the afternoon.

SAFESEANET INTERFACE GETS MAKEOVER



Two recent upgrades have improved the SafeSeaNet service EMSA offers to users. Firstly, the interface now displays data on nautical charts, making it easier and faster to obtain information. Secondly, the 'incident report exchange' has been expanded based on feedback from a two-year consultation. Details on a vessel involved in an accident or incident will now be updated and distributed to Member State authorities along the planned route of the ship. Member States tested the new functions during a series of training sessions held in EMSA and Belgium and gave very positive feedback. Further training will be given in 2014 and Member States are invited to express their interest to participate.


INTERNATIONAL SAFETY MANAGEMENT TRAINING FOR IPA COUNTRIES



Greater insight possible through simulated auditing scenarios

A two-day course for candidate and potential candidate countries was held at EMSA on 14-15 January. The course focussed on a simulated ISM audit for passenger ships and was delivered by two representatives from the Italian Coastguard and an EMSA expert. Officials attended from Albania, Bosnia and Herzegovina, Montenegro and Turkey. The course covered several case studies, examining possible problems and how these could be tackled. The idea is to help participants develop a practical approach to passenger ship auditing techniques, and to improve their understanding of the latest ISM Code changes.
