The evidence provided by each member of the group will be checked to ensure that the group as a whole fulfils the criteria. Accordingly, yes, please provide the required economic and financial capacity evidence for the two companies owning the newly established company. Regarding the evidence for the newly established company, please refer to the text enclosed under point 11.3 (Economic and financial capacity – Selection criteria) of the Request Specifications which reads as follows: " <i>If, for some exceptional reason which EMSA considers justified, a candidate is unable to provide one or other of the above documents, he may prove its economic and financial capacity by any other document which EMSA considers appropriate. In any case, EMSA must at least be notified of the exceptional reason and its justification in the tender. EMSA reserves the right to request at any moment during the procedure any other document enabling it to verify the tenderer's economic and financial capacity."</i>
