Subject & requirements	<p>Provision of flags</p> <p>The purpose of this contract is the provision of flags, flag poles and their accessories at any moment. EMSA uses flags outside the Agency, at its entrance hall, in ships, in the conference centre and in meeting rooms.</p> <p>Additionally, the EMSA flag is used in EMSA, on vessels and in locations of EMSA activities.</p> <p>The tenderer must be able to provide all item types listed in Appendix II and shall provide their full catalogue(s) of items available for purchase, which should contain a large range with description, mentioning the model and characteristics of each item.</p> <p>Prices quoted in Appendix II must be fixed amounts and non-revisable unless otherwise specified in the contract.</p> <p>The Agency reserves the right to request quotations for one-off purchases outside the Appendix II listed supplies. In that case, the contractor shall receive a request for quotation by e-mail to which they must provide an offer as per contractual provisions.</p> <p>The tenderer shall take into consideration the following minimum requirements when preparing their offers (including price offers):</p> <ul style="list-style-type: none"> • Flag materials shall be of high-quality nylon or polyester to ensure high durability; • Outdoor flags shall have all-round hems with double stitching; • Outdoor flags materials must meet the atmospheric conditions to which these may be exposed, particularly strong winds and UV rays; • Flags must respect the official colours/pantones of their countries or the specifications of the EMSA logo. <p>Please see Appendix II: Supply price list</p>
